- Location:** Freedom Lake Park, 9990 46th Street North, Pinellas Park, FL 33782
- Measurement:** A measurement certificate is required to participate. Verification may be conducted on site as result of a protest or as determined by the Regatta Director. At the beginning of each day of the event a contestant shall declare one "boat", consisting of one hull, one keel (with its ballast), one rudder and up to four rigs. In the case of loss or damage to the "boat" such that it can no longer be sailed, the contestant may declare a replacement set.

Or, by completing the attached Entry Form and submitting it prior to March 13, 2019 with an entry fee of \$32.00, guests \$8. Entry fee and guest lunch fee includes: doughnuts, drinks and lunch on Saturday; doughnuts and drinks on Sunday. (Does not include dinner on Friday or Saturday.)

Race Format: Racing will be conducted under a single heat system, promotion-relegation. To start the regatta, skippers will be placed in either the A- or B-fleet based on the National Seeding List. No seeding heats. Courses will be set based on the prevailing conditions and announced prior to the start of each race. The sailing instructions can be found at http://www.floridaec12.com/Sailing_Instructions.pdf. Copies will be provided at the regatta.

Scoring: The regatta will be scored in accordance with the Low Point Scoring system as set forth in Appendix A of the RRS. The worst finish for each boat shall be excluded after a minimum of 6 heats are sailed; an additional second worst score will be excluded after twelve heats are sailed.

Prizes: Minimum of five (5) trophies plus AMYA Chevrons (Red).

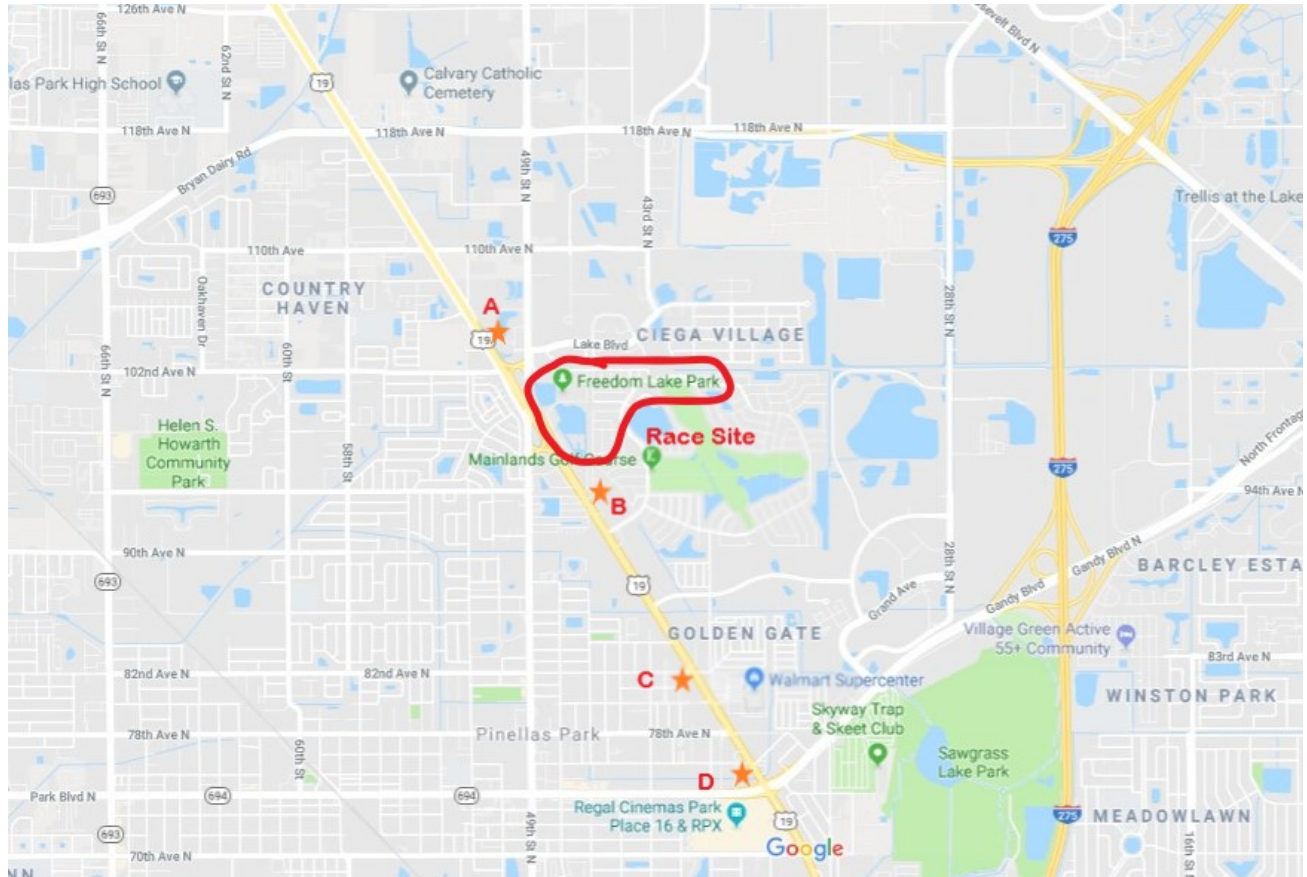
